A Conference First-Timer's Random Thoughts and Initial Impressions

Prior to becoming a technical writer two years ago, the only full-time work I ever had was as a locksmith for my grandfather's security system company in Canada. After a stint writing manuals for a surveillance software and service company, I left the chilly north last year to take a job with an Orange County, California, investment firm to work in the Policies and Procedures Department.

My company has plans to publish all our policies and procedures online and eventually adopt an Intranet. Last spring, I asked my boss if I could attend the STC conference in Cincinnati to learn about these P&P issues. He said he would prefer for me to go to the conference to "take in the big picture of technical writing" because I'm new to the profession. I said, "Groovy," which is what you can say to please an "Idon't-sweat-the-details" millionaire surfer who happens to be your boss.

And so it came to pass that I was an STC Annual Conference "greenhorn" with specific instructions when I attended the event last spring. Until that morning in May, I had never traveled to any convention. Nevertheless, I came, I saw, I ate some Cincinnati-style chili, and I toured the world of technical communication outside the realm of P&P.

Here are some of my first impressions and random thoughts about my experience.

Conference offerings I considered obligatory were first-rate and fun. The best among them were the aptly named "First-Timers' Session" and "Opening Session."

It was stirring to hear the heartfelt remarks about technical communication that were given by the passionate professionals who were this year's STC exemplars.

One of my favorite aspects of the conference was the spontaneous, generosity

of STC veterans. While waiting for a session to begin and wondering absently about how good the latest version of Adobe Acrobat really was, a fellow sitting next to me said, "The latest version of Acrobat is fantastic. You'll love it." I asked him why, and the 11year STC member told me in spirited and lengthy detail.

The most useful session speakers shared the nittygritty of how to meet technical communication objec*tives.* These participants offered nuts and bolts know-how about surviving and thriving in the wild, wild world of technical communication. For me, two sessions that hit this mark were "How We Built Our Tech Pubs Intranet Site with Cheap Stuff" and "Oh! Oh! The Job Ad Says OO!"

One of the most amusing conference quotes I heard came from Whitney Quesenbery during her session, "Search Interfaces: The Good, the Bad and the Ugly," when she said, "The Web is the largest flat file we've ever searched."

The uncommercial appeal of the vendors' hall came courtesy of its commercial nature. These vendors seemed to recognize that it would be better to pursue conferenceparticipants with trinkets and raffles rather than with high-pressure click-here, buy-now hype. I liked that, especially since I was there on an "information gathering" mission.

The range of technical session topics allows a curious newcomer to dip her toes in whatever fresh pond seems appealing. The sessions varied only slightly in quality (none I attended were expressly bad), and I was grateful for the dearth of Reddi-Whipped professional wisdom dispensed during the sessions.

I came away from Cincinnati thinking that one size does not fit all when it comes to attending a conference. The experience can begin with asking yourself how you feel about technical writing, what your professional goals and interests are, and how you would like to get to know the conference environs. By starting with the human element, you can take the STC offerings and create a plan unique for you.

You also can go to the conference confident that you will receive many fine things including a book bag, access to the profession's leading technical writing practitioners programs that offer compelling ideas about technical communication.

It was a great experience, and my first conference isn't likely to be my last. I'm already planning for the next year's conference in Orlando, Florida.

And she has offered to serve as an advisor to the team's new leader. The position also could be filled with coleaders. For example, one member has expressed an interest in handling the liaison function for the Canadian chapters if someone else were able to do the same for the U.S. chapters. If you want to take on the liaison job for both countries, that would work as well. The point is, you don't necessarily have to do it alone. Team members could be enlisted to help.

STC Listserves Undergo Changes

The society office has moved all Listserv mailing lists to a new server and has replaced the Majordomo listmanagement software with Lyris. Lyris is an interactive, Web-based list-management program that offers a number of features that were not available with Majordomo. For list managers that means no longer having to rely on email transactions for administering the list. Such transactions can be done interactively on the Web. For subscribers, Lyris offers digest and archive functions, which means you now have the option of receiving daily digests of postings to the list and viewing old messages online through Web-based archives.

The change to Lyris also brings with it an address change for posting messages to the SIG's Listserv. Starting now, please use the following address:

stcppsig-l@lists.stc.org

Note that the character after the hyphen is a lowercase letter L — not the number one. Note also that there is a possibility that the new address will change.
